Ways to Give

A Bequest

A bequest is a gift included in your will or living trust, a flexible and time-honored way to establish a lasting legacy.

A Gift of Retirement Assets

A gift of retirement assets, such as 401(k) plans or IRAs, may allow you to give generously while also reducing taxes that may otherwise consume those assets. You can list the Foundation as a beneficiary on either of those plans, indicating either a dollar amount or a percentage.

Gifts of Life Insurance Policies

Gifts of insurance benefits can be shared with the ASSE Foundation. It's as simple as making the Foundation a beneficiary of your life insurance policy.

How to Give

Determine whether you would like your gift to be a specific amount, or a percentage which allows your gift to remain in proportion to your estate size.

Decide if you wish to direct your gift to wherever our need is greatest, or to the specific project your care most about.

Speak with your attorney to make the necessary changes to your will or revocable living trust. Or, simply make us a beneficiary on your 401(k), IRA, or life insurance policy.

If you desire, please notify us of your intention so we can thank you and keep you informed of our programs and progress. Of course, we are also happy to adhere to your wishes regarding anonymity.
